Subject: Implementation of the school safety guidelines issued by the National Disaster Management (NDMA) in order to comply with the directions of the Hon'ble Supreme Court of India Order dated 14.08.2017-reg.

Dear Sir/Madam,

This has reference to the above subject and CBOSE Circular No 05/2018 dated 27.03.2018, where an advisory has been issued to all the affiliated schools for adherence to the comprehensive guidelines and procedure framed by NDMA and NCPCR related to safety of children in school. Further, the Board is in receipt of letter dated 05.01.2021 from the Director General Open School Education, Uttar Pradesh wherein it is informed that schools located in the State of Uttar Pradesh are not serious in implementing the comprehensive guidelines of NDMA. It is hereby reiterated to ensure compliance of various provisions of Affiliation Bye-Laws of the Board which has been issued for implementation of comprehensive guidelines of NDMA and NCPCR related to safety of children in school.

The affiliated schools are directed to fill-up the information on E-Uttar Pradesh portal so that information should be compiled from there, which is related to Safety of children in school. In case of any deviation on the above guidelines is noticed, the Board would be constrained to take further action, under the Affiliation Bye Laws including initiating action for disaffiliation of the school. This issue with the approval of the Competent Authority of the Board.
