In this connection, it is to clarify to all stakeholders and general public that the Board has neither appointed/authorized any agency/advisors to offer affiliation related services nor the Board encourages such unethical practices. The Board has revamped the affiliation process from 2021 to make it hassle-free and transparent. It relies on self-certification, public disclosure and data analytics. Filling up the form/details have been simplified and made easy. The requirement for affiliation, related documents, time line for application is available at link <https://cbose.com> Therefore, it is brought to the notice of all stakeholders that in case of any query/difficulty in the affiliation process, they may contact Affiliation helpline at 9557351231, or write to us at [cbose.aff@.com](mailto:cbose.aff@.com) For convenience and ease of doing business, the Board has already uploaded training videos with step by step instructions for guiding the schools in initiating necessary actions for applying for affiliation process of the Board. The Board also requests to all the stakeholders and general public not to act on the basis of such false claims and visit Board's affiliation website at link: [www.cboseaff.com](http://www.cboseaff.com) or refer CBSE affiliation bye-law Manual for information and activities of the Affiliation. Anyone involved in such activities are also hereby warned and advised to refrain from giving such misleading information. In case, any such information comes to the notice of the CBOSE, the Board shall initiate necessary action as per provisions of law.
