Declaration of Result – Stream 1 (Block 1), 2023

It is hereby notified for the information of all affiliated study centres, regional offices, district academic monitoring cells, evaluation units, digital certification divisions, academic coordinators, and all other stakeholders associated with the functioning of the Central Board of Open Schooling & Examination (CBOSE), that the Board has completed the formal process of compilation, verification, evaluation, moderation, authentication, and finalisation of the marks pertaining to the Class X and Class XII examinations conducted under Stream 1 (Block 1), 2023. Accordingly, the result for the said examination cycle shall be formally declared on **05 June 2023** on the official website of the Board as well as through the digital student dashboard.

The declaration of results marks the culmination of a long, multi-layered academic and administrative exercise undertaken by the Board, beginning with the conduct of practical examinations in February, the organisation of theory examinations from March to April, the consolidation of attendance records, the sealing and secure dispatch of answer scripts, their systematic evaluation by qualified evaluators, the scrutiny of practical marks submitted by study centres, and the verification of documentation submitted for each learner. The Board underscores that the result declaration is not merely a mechanical process but a meticulous academic determination that reflects the learner's performance across both theoretical and practical domains, ensuring fairness, transparency, and accuracy at each stage.

The Board acknowledges that large numbers of learners from across the country, and in certain cases abroad, participate in the Stream 1 (Block 1) examination cycle. These learners represent diverse age groups, socio-economic backgrounds, linguistic communities, and academic trajectories. The Board therefore recognises the responsibility placed upon it to ensure that the result declaration is conducted without error, delay, or compromise in academic standards. To this effect, a comprehensive verification mechanism has been implemented by the Board involving multi-level data matching techniques, auditor reviews, statistical checks, and cross-validation of entries submitted through the student portal and the institutional dashboard.

The results will be available to learners securely through the official website and their login credentials. Learners are advised to access the results only through authorised platforms of the Board and to avoid relying on unofficial portals, third-party websites, or unverifiable sources. The Board shall not be responsible for any inconvenience arising out of misinformation accessed from unauthorised channels. The digital marksheet generated on the student dashboard shall be treated as an authentic document for the purposes of admission, employment, verification, and all academic uses until the physical certificates are issued.

The Board further notifies that the digital marksheet shall include the learner's personal details, subject-wise marks, practical marks, overall grade, internal assessment records where applicable, final result status, and eligibility for migration certificate. The digital document shall be secured with QR-based authentication tools and verification mechanisms that allow institutions, universities, employers, and other authorities to confirm the validity of the certificate through the official verification portal. This digital verification platform ensures transparency and prevents the misuse of forged documents.

Study centres are instructed to provide guidance and administrative assistance to learners after the declaration of the result. Centres must make arrangements to explain to learners how to download their marksheet, how to apply for migration or transfer certificates, how to interpret the grading system, and how to proceed towards admission in higher academic programmes or vocational streams. Under no circumstances shall any institution charge unauthorised fees for result-related support services. All fee structures shall remain as prescribed by the Board.

The Board emphasises that the result prepared for each learner is based strictly on documented academic evidence, answer book evaluation, practical assessment records, and data submitted by centres. No request for alteration, manipulation, or modification of result based on personal grounds, emotional appeals, or institutional preferences shall be entertained. However, learners who wish to apply for rechecking or re-evaluation, wherever permissible under Board regulations, shall be allowed to do so through the official portal once the rechecking window opens. The detailed procedure for the same shall be issued in a separate Notification.

The Board also clarifies that in rare cases where the result of any learner is withheld due to incomplete data, mismatched records, suspected discrepancies, or pending verification of practical marks, such learners shall be informed individually through their student dashboard. Institutions must extend cooperation in resolving such cases by submitting the correct and authentic documents within the timeframe prescribed by the Board. The Board shall release the pending results only after all required verifications are completed satisfactorily.

The Outcome-Verification Team of the Board has been instructed to maintain continuous coordination with the Regional Data Units to ensure that any technical issues faced by learners during result download are addressed promptly. Servers shall be fortified with additional resources to handle high traffic volumes on the day of the declaration. However, learners are advised to remain patient in case of temporary delays due to simultaneous access by thousands of users.

The Board takes this opportunity to recognise the academic efforts of learners who have completed their preparation under various constraints, including personal responsibilities, employment obligations, distance barriers, or special learning needs. The CBOSE framework supports inclusive education and accommodates learners who pursue studies through flexible learning pathways. The declaration of the result is a key milestone in their academic journey and the Board wishes all successful learners a bright future ahead.

Institutions must note that all study centre records, including attendance sheets, practical files, answer book dispatch logs, and digital submission receipts shall remain preserved until further instructions are issued. These documents may be required for audits or academic reviews and must be kept securely without alteration.

This Notification must be displayed prominently on all institutional notice boards and circulated through digital platforms used for academic communication. All concerned officials are required to adhere strictly to the instructions contained herein.

This Notification supersedes all earlier communications issued regarding the declaration of results for Stream 1 (Block 1), 2023.
