Dear Sir/Madam

It is hereby notified that March 2023 shall be treated as the month of academic consolidation and final pre-examination preparation for all affiliated institutions under CBOSE.

All centres shall review their affiliation status, ensure compliance with infrastructure and faculty norms, and keep affiliation documents ready for inspection. Institutions must continue to align teaching, assessment and administration with current Government of India education policies and NEP-oriented guidelines.

Syllabus completion, revision, internal assessment and practical work must be finalized within March. Examination halls, labs and strong rooms must be checked and kept ready for the forthcoming examination schedule.

All Board-related fees due from institutions shall be deposited within notified dates. Nominal Rolls (NR) must be error-free, with correct subjects, photographs and student details; no unverified data shall be accepted.

Internal assessment records and practical marks must be properly maintained, as the same will be used for result compilation and publication.
