It is hereby notified that June 2023 shall be observed as **Open School Affiliation Strengthening Week (OSASW-2023)** across all CBOSE-affiliated institutions. The purpose of OSASW-2023 is to reinforce institutional governance, ensure compliance with Board affiliation norms, and establish higher standards of academic and administrative discipline.

All institutions must conduct a comprehensive internal audit of their infrastructure, faculty qualifications, classroom conditions, laboratory readiness, sanitation, safety certification and administrative documentation. Affiliation certificates must be visibly displayed, renewal files must be updated and all mandatory records must be arranged for immediate inspection.

Institutions must also ensure transparency in academic services, student support mechanisms, communication channels and grievance redressal systems. Centres are instructed to avoid any misleading academic claims or unauthorized use of the Board's name during OSASW-2023.

Student documentation, fee records, NR data and assessment files must remain accurate and verifiable. The Board may conduct random affiliation compliance inspections during the week.

This notice must be displayed on all official institutional platforms.
