Dear Sir/Madam

It is hereby notified that July 2023 shall be observed as the **Open School Quality Assurance Cycle (OSQAC-2023)** across all CBOSE-affiliated institutions. This special cycle aims to strengthen academic quality, institutional governance, student support mechanisms and compliance with national educational standards.

All affiliated centres must conduct a quality audit of their academic delivery, learning resources, classroom discipline, teacher preparedness and student feedback systems. Institutions must ensure that learning materials, revision plans, internal assessments and practical records meet expected standards of quality and fairness.

Administrative systems—including admission documentation, fee receipts, NR data, examination files and grievance redressal logs—must be verified for accuracy and transparency. Any lapses must be corrected immediately during OSQAC-2023.

Institutions must promote student wellbeing, counselling access, academic guidance and equal learning opportunities. Centres must avoid misleading academic claims and maintain ethical conduct at all levels.

This notice must be displayed across all official institutional communication channels.
