Dear Sir/Madam

It is hereby notified that August 2023 shall be observed as the **Affiliation Renewal Scrutiny Month** for all institutions functioning under CBOSE. All affiliated centres whose affiliation period is due for renewal in 2023-24 must complete mandatory documentation, compliance checks and institutional verification within the notified timeline.

Institutions must prepare updated infrastructure records, faculty qualification files, building safety certificates, sanitation and hygiene records, laboratory readiness reports, fire safety compliance, administrative registers and student enrolment data. All documents must be arranged clearly and kept ready for digital or physical scrutiny.

Institutions are strictly instructed to ensure that no misleading promotional material, unauthorized recognition claim or unapproved academic announcement is issued during this period. Every centre must present the accurate status of its affiliation without alteration or misrepresentation.

Affiliation Renewal Scrutiny Teams may conduct scheduled or surprise inspections. Institutions must cooperate fully and provide all required documents immediately.

This notice must be displayed on official institutional channels.
