Subject: Open School Academic Monitoring Cycle (OSAMC–2023) for All Affiliated Centres

Dear Sir/Madam

It is hereby notified that September 2023 shall be observed as the **Open School Academic Monitoring Cycle (OSAMC–2023)** across all CBOSE-affiliated institutions. The purpose of OSAMC–2023 is to evaluate the academic performance, learning environment, faculty preparedness and student progress across Open School centres.

All institutions must conduct a detailed academic review covering syllabus completion, assignment status, internal assessment quality, practical readiness and student academic engagement. Institutions must ensure that teaching-learning processes remain structured, transparent and aligned with national educational standards.

Centres must update their academic records including attendance logs, teacher diaries, lesson planning files, project work documentation and internal assessment sheets. Any academic backlog must be cleared within the OSAMC period.

Institutions must also assess student learning gaps and arrange revision classes, remedial sessions and academic counselling wherever required. The Board may conduct random digital or physical reviews of academic documentation.

This notice must be displayed on all official institutional channels.
