It is hereby notified that October 2023 shall be observed as the **Mid-Term Student Counselling Initiative (MSCI-2023)** across all CBOSE-affiliated institutions. The objective of MSCI-2023 is to strengthen student support systems, reduce academic stress, ensure emotional well-being, and provide structured guidance before the year-end assessment cycle.

All affiliated centres must organize dedicated counselling sessions focused on academic planning, examination readiness, time management and stress management. Institutions must ensure availability of trained counsellors, faculty mentors and academic advisors for student interaction.

Students facing learning gaps, low motivation, attendance issues or practical backlogs must receive timely assistance. Institutions must maintain a supportive environment that encourages open discussion and problem-solving.

Centres must also verify that all academic records, internal assessments and project work of mid-term students remain updated to prevent examination pressure. Parent-teacher interactions may also be conducted where necessary.

This notice must be circulated across all institutional notice boards and official digital groups.
