Institutions whose affiliation is due for renewal must complete all compliance submissions, update faculty documents, verify infrastructure readiness and ensure availability of safety certifications.

All affiliated centres must participate in the **Digital Data Accuracy Drive**, ensuring that student identity records, subject selections, photographs and demographic details are error-free before the next examination cycle. Any inconsistency must be rectified immediately.

Institutions must also verify examination-related arrangements including CCTV monitoring, hall readiness and documentation continuity. Internal assessment sheets, attendance logs and project files must be maintained for audit.

Centres must avoid any misleading promotional material or unauthorized representation of the Board's authority. Transparency and academic integrity remain mandatory.

This notice must be displayed across all official institutional platforms.
