Any corrections after November may not be entertained. Internal assessment sheets, practical records and project files must be updated and preserved for review.

All affiliated institutions must also undergo an **Affiliation Audit Check**, ensuring that compliance documents—faculty files, safety certificates, building records and administrative logs—are fully updated.
