It is hereby notified that January 2025 shall be observed as the **National Institutional Compliance Strengthening Cycle (NICSC-2025)** across all CBOSE-affiliated institutions.

The Cycle aims to ensure reinforced governance, transparent academic planning, and standardized operational discipline under the updated educational guidelines of the Government of India.

Institutions must conduct a full-spectrum review of infrastructure readiness, faculty qualification records, safety documentation, digital data accuracy, and administrative transparency. All affiliation-related records must be updated and kept ready for scrutiny as per the strengthening norms of 2025.

Examination-related preparatory activities for the new session—including internal assessment planning, practical readiness and student identity verification—must begin immediately. Centres must maintain strict academic discipline to support national-level standardization.

Institutions must also verify and update student records for the January NR window and ensure error-free data submissions. Fee-related obligations must be cleared within prescribed timelines.
