Dear Sir/Madam

It is hereby notified that February 2025 shall be observed as the **National Academic Digital Reform Phase (NADRP–2025)** for all CBOSE-affiliated institutions. This nationwide reform phase, emphasizes upgraded digital governance, institutional data accuracy and transparent electronic academic workflows aligned with modern educational directives of the Government of India.

All institutions must verify and digitize their academic documentation, including student records, internal assessments, faculty profiles, attendance registers, practical evidence and administrative logs. Centres must ensure that no manual discrepancies exist, and all entries match official records.

Institutions must upgrade their digital readiness—ensuring proper functioning of academic portals, online NR data systems, digital identity verification tools and institutional dashboards. Cyber-secure examination preparation, including encrypted document handling and digitally authenticated seating plans, must begin during this phase.

Affiliation-related digital files must be updated, restructured and kept ready for system-based scrutiny. Fee submission logs must be stored digitally and made audit-ready.

This notice must be displayed across all official institutional platforms.


