Dear Sir/Madam

It is hereby notified that March 2025 shall be observed as the **National Examination Integrity & Security Protocol (NEISP–2025)** month across all CBOSE-affiliated institutions. This national initiative aims to reinforce examination purity, eliminate malpractice risks, and establish upgraded security systems under the 2025 Academic Integrity Guidelines.

All centres must conduct a rigorous inspection of examination halls, CCTV equipment, biometric entry points, strong room locking systems and digital storage protocols for confidential material. Any malfunction must be rectified immediately.

Institutions must ensure strict monitoring of internal assessments, practical evaluations, project submissions and viva documentation. All assessment records must be authenticated and preserved in secure digital and physical form.

Student identity verification is mandatory, and centres must eliminate duplicate or unverified entries. Examination staff must undergo updated security orientation as per NEISP–2025 standards.

Affiliated institutions shall be responsible for maintaining complete transparency in examination processes and ensuring zero-tolerance compliance with integrity norms.

This notice must be displayed on all official institutional platforms.
