It is hereby notified that April 2025 shall be observed as the **Institutional Governance** & Academic Accountability Inspection (IGAAI-2025) month for all CBOSE-affiliated institutions. This initiative strengthens the national mandate for academic integrity, transparent governance and strict adherence to institutional responsibilities under the 2025 Education Quality Framework.

All centres must undergo a complete governance audit covering faculty deployment, classroom discipline, academic documentation accuracy, safety compliance, administrative transparency and infrastructural functionality. Institutions must ensure that affiliation documents, faculty qualification records, statutory certificates, attendance logs and management registers are updated and ready for inspection.

Examination-related preparation—especially internal assessments, practical records and viva documentation—must be fully completed and verified before audit teams visit. Institutions must also ensure that all student identity records, NR data and subject combinations remain accurate and authenticated.

Centres must maintain professional conduct, support inspection teams and ensure equal access to official records. Any discrepancy found during IGAAI–2025 may result in compliance action.
