It is hereby notified that May 2025 shall be observed as the National Academic Risk & Compliance Audit Phase (NARCAP-2025) across all CBOSE-affiliated institutions. This phase aims to identify academic risks, strengthen compliance systems and ensure institutional readiness for the mid-year governance cycle under the updated national education mandates.

Institutions must conduct a thorough review of academic delivery, internal assessment records, practical evidence, project documentation and student progress reports. Any risk areas—such as incomplete academic files, irregular attendance logs, outdated infrastructure records or pending faculty documentation—must be corrected immediately.

Centres must ensure complete **Compliance Readiness**, including updated safety certifications, affiliation records, statutory documents, digital accuracy of NR data and transparency in administrative records. Institutions must maintain audit-ready documentation for any scheduled or surprise inspection.

Examination-related arrangements, especially for upcoming practical or internal assessments, must be finalized with full security and governance discipline.
