Subject: July 2025 National Institutional Digital Security & Data Governance Cycle (NIDSDGC-2025)

Dear Sir/Madam

It is hereby notified that July 2025 shall be observed as the **National Institutional Digital Security & Data Governance Cycle (NIDSDGC-2025)** across all CBOSE-affiliated institutions. This cycle focuses on strengthening cyber governance, securing academic data and ensuring compliance with national digital security standards.

Institutions must conduct a mandatory evaluation of their digital systems, including academic portals, NR data servers, student record software, CCTV storage devices and all institutional digital communication channels. Any outdated or vulnerable system must be immediately upgraded or secured.

All centres must ensure that student records, assessment files, attendance logs and faculty data stored digitally are encrypted, backed up and protected from unauthorized access. Institutions must strictly avoid sharing examination-related or student-sensitive data through unverified digital platforms.

Affiliation-related digital documents, statutory certifications and administrative logs must be updated and secured in compliance with the 2025 Digital Governance Protocol.

This notice must be displayed across all official institutional platforms.
