(NAAVEC–2025)

Dear Sir/Madam

It is hereby notified that September 2025 shall be observed as the **National Academic Authenticity & Verification Enforcement Cycle (NAAVEC–2025)** across all CBOSE-affiliated institutions. This enforcement cycle aims to ensure complete authenticity, transparency and verification accuracy in all academic and administrative processes.

All institutions must conduct strict verification of student records, photograph authentication, identity documents, subject combinations and NR-linked data. Incorrect, manipulated or unverifiable entries must be corrected immediately.

Internal assessment sheets, practical records, project files and viva documentation must be authenticated by designated faculty members and preserved securely for inspection. The Board may initiate random audits to ensure conformity with NAAVEC–2025 standards.

Affiliated institutions must also verify the authenticity of faculty qualification documents, statutory records, building certifications and administrative files. Any discrepancy or misrepresentation may lead to disciplinary action.

This notice must be communicated through all official institutional platforms.


