**SUBJECT: RESULT DECLARATION PRESS BRIEFING FOR THE JUNE 2023
EXAMINATION**

Madam/Sir,

The Central Board of Open Schooling & Examination (CBOSE) conducted a formal *Result Declaration Press Briefing* to announce the outcomes of the June 2023 Board Examination. This national event served as a crucial academic milestone for lakhs of open schooling learners across India who appeared for Class X and XII examinations through the flexible and inclusive framework of CBOSE. The press briefing brought together media representatives, institutional leaders, examination coordinators, academic experts, policymakers, and officials from various departments of the board. The event emphasized not just the numerical outcome of the examination but also the broader significance of open schooling in enabling educational continuity for diverse learning communities.

The ceremony began with a detailed presentation by the Controller of Examinations, who discussed the overall performance trends observed during the June 2023 cycle. He highlighted that open schooling candidates often come from varied life circumstances — including individuals who are employed, self-learners, students who transitioned from mainstream schooling, women returning to education, rural youth, adult learners, and those who require a second opportunity to complete their schooling. The briefing stressed that the efforts of such learners reflect resilience and commitment, making their examination performance a powerful testament to the inclusive academic model upheld by CBOSE.

During the event, CBOSE unveiled the official *Student Performance Report 2023*, which provided comprehensive insights into subject-wise performance, region-wise trends, improvement patterns among repeat learners, and the success rate of candidates utilizing credit transfer and on-demand pathways. Officials mentioned that the board witnessed significant participation in skill-based and vocational subjects, reaffirming the growing demand for practical and employment-aligned learning under the open schooling model.

The report also reflected improved outcomes among learners who used digital study resources launched earlier in the year, indicating that resource accessibility directly strengthens examination preparedness.

One of the most important announcements made during the briefing was the introduction of the *Digital Certificate Verification Portal*. This new system enables educational institutions, employers, and government authorities to instantly verify the authenticity of CBOSE-issued marksheets and certificates using encrypted QR-based validation technology. The portal enhances transparency, prevents document manipulation, and aligns with the broader national movement toward digital governance and paperless authentication. By launching this portal, CBOSE reinforced its dedication to ensuring integrity, trust, and recognition for its learners worldwide.

The event also celebrated the outstanding performance of several learners and study centres across India. While open schooling is not a competitive environment, CBOSE acknowledged institutions that demonstrated exemplary commitment in guiding learners, conducting practical sessions, maintaining examination discipline, and supporting technologically disadvantaged students. These institutions were commended for their proactive involvement in spreading awareness about open schooling and their role in building community-level confidence in alternative pathways of education.

A number of media questions were addressed during the interaction segment of the briefing. Journalists sought clarity on evaluation reforms, reassessment procedures, the functioning of on-demand examinations, policies for absentees, and measures introduced to maintain examination integrity. Officials responded by explaining that CBOSE is continuously upgrading its evaluation mechanisms through digital monitoring, double-check validation, standardized marking rubrics, and timely redressal protocols. The Controller of Examinations assured that the board is committed to reducing delays in rechecking, expediting result processing, and providing clear communication to learners regarding their academic requirements.

The briefing concluded with a strong message of encouragement to all learners. The Chairperson of CBOSE emphasized that the results do not merely determine academic progress; they represent a personal milestone in the journeys of individuals who return to education with determination and hope. He reminded learners that open schooling is built on the belief that education is a lifelong right and that personal circumstances—whether economic, social, or family-related—should never restrict someone from achieving academic success. CBOSE reaffirmed its commitment to expanding digital support, strengthening regional infrastructure, and enhancing learner services in the coming academic cycles.
