Over the last decade, CBOSE has received feedback from evaluators, institutions, and students regarding the challenges of manual evaluation—variations in marking patterns, evaluator fatigue, limited cross-checking, and the difficulty of monitoring assessment quality across hundreds of examination centres. To address these issues and align with global academic excellence standards, CBOSE has integrated Artificial Intelligence (AI), Machine Learning (ML), digital scanning, and anomaly detection technology into the entire evaluation cycle.

Under this system, all written answer sheets will be digitally scanned and processed through the National Digital Evaluation Grid. AI-assisted tools will identify marking variations, scanning errors, page discrepancies, skipped questions, incorrect total marks, and pattern inconsistencies. The system does not replace human evaluators but enhances their efficiency and ensures quality-control. Evaluators will receive AI-highlighted sections requiring attention, enabling them to make accurate decisions while maintaining academic sensitivity.

AAGS-2025 significantly reduces human error, supports uniform marking, and ensures that every learner—irrespective of background or location—receives a fair evaluation. It further provides a detailed performance analytics report for internal use, helping the Board improve question design, subject clarity, and examiner guidelines.
